## St Simon Stock's 100 Club (Parish Lottery) Terms & Conditions

### Please keep for your information.

1. This is a Fundraising Scheme known as **St Simon Stock 100 Club**. Everyone aged 16 years or over can subscribe to enter the Monthly Draws.
2. The object of the 100 Club is to raise funds for the Parish via the sale of **Lottery Numbers**. After paying out all prize money, the profit goes to the Parish Development Fund Account, contributing to meet the cost of development/maintenance projects in the Parish.
3. The 100 Club is run by a parish volunteer who is the Administrator, on behalf of the Parish Priest of St Simon Stock Church who is the Promoter.
4. Subscribers are invited to purchase any amount of **Lottery Numbers** at £12 **per number per year**, payable in advance annually in February by Standing Order (recommended), cash (placed in an enveloped and clearly marked: ***"For the 100 Club from:....your name"***), or cheque made payable to: St Simon Stock 100 Club.

Withdrawal can be made at any time during the subscription period, but please inform the Administrator so that your numbers can be taken out of the monthly draws or allocated to someone else. Thank you.

5. All **Lottery Numbers** purchased will be recorded in a Register and used for the Monthly Draws, which will be drawn at random by computer. **Lottery Numbers** purchased are not transferable except in the circumstance when a subscriber dies and a next of kin wishes to have that number transferred to them.

The results of the Draws will be published in the Parish Newsletter each month and on the Parish website. All winners will be sent a cheque by post to their home address so it is important to complete the Entry Form clearly with the name which should be used when issuing the cheque for any prize won. Occasionally, winning cheques may also be presented after Mass on the Sunday immediately following the Draw.

6. For 10 months of the year the Prizes are:      1<sup>st</sup> Prize: £50.00      2<sup>nd</sup> Prize: £25.00

In addition, at **Easter and at Christmas** there are Special Prizes as follows:

**1<sup>st</sup> Prize: £100.00**

**2<sup>nd</sup> Prize: £50.00**

**3<sup>rd</sup> Prize: £25.00**

7. No prize will be paid or delivered to any person other than the eligible subscribers to whom the winning numbers were allocated or to a representative nominated by the subscriber in writing to the Administrator in advance. Except in the circumstance when a subscriber dies during the period of subscription, in which case the prize will be paid to the next of kin together with a refund of the amount of pre-paid subscription remaining.
